# Optometric Assisting



Optometric Assistants work directly with eye doctors to determine the best course of action for each patient. Every patient is unique, with their own particular needs and it is the eye care team's job to satisfy those needs. This may come through pre-testing, contact lens training, lifestyle dispensing, frame and lens selection or final frame dispensing. There is an endless array of options for each patient and a great sense of satisfaction is derived from helping to improve someone's vision.

Eye care is a lower stress, clean environment profession with many opportunities within the field. Graduates can find employment in the offices of Optometry, Ophthalmology, retail opticals and optical laboratories. According to the United States Department of Labor, employees in the medical field will enjoy the greatest number of opportunities with 5.7 million new jobs projected between 2010 and 2020.

#### **PROGRAM CONTENT**

The Optometric Assisting training curriculum is a blend of classroom, laboratory and clinical instruction. Included in Optometric Assisting training are:

- Extensive, supervised externship
- Theory and practical experiences in business management skills
- Testing skills to determine defects in vision
- Preparation and fitting of eyeglasses and contact lenses
- Ocular anatomy and physiology
- Employability skills and other courses

### **ACCREDITATION**

The Optometric Assisting program is recognized by the ParaOptometric Section of the American Optometric Association.

#### **PREREQUISITES**

Applicants who have a standard high school diploma or its equivalent from a regionally accredited institution, meet the state-mandated minimum basic skills requirements on the Test of Adult Basic Education (TABE), and interview with the program counselor may enter the program during the next enrollment period. All students must complete a physical examination and immunization record prior to acceptance.

#### **INDUSTRY CERTIFICATION**

Students will be prepared to take an approved state and/or nationally recognized industry certification or licensure exam in their field of study.

#### **ARTICULATION**

Upon completion and meeting eligibility requirements, students may be awarded credits toward an Associate Degree by selected Florida State Colleges.
