### **Pharmacy Technician**



he Pharmacy Technician program offers instruction necessary for employment in the profession of pharmacy as a licensed pharmacy technician. Students will learn how medications work in the body, how to calculate and ensure safe doses. screen for drug interactions and side effects as to ensure that the patient's medications are dispensed correctly. Class theory is reinforced with 400 hours of on-site training in both a community and hospital pharmacy settings. In the Pharmacy Technician program the student will learn all aspects of pharmacy practice to assist the pharmacist providing safe and effective healthcare to the patient in any discipline. Pharmacy Technicians will see a continuing expansion of their role in the pharmacy, assuming the day-to-day duties the pharmacist traditionally performed, thus allowing the pharmacist to become more involved in patient care and more critical tasks. The pharmacy technician career path is a high demand profession, according to the US Bureau of Labor statistics and is expected to grow by 31% over the next decade.
