## Program Description

The Adult General Education (AGE) program is designed to remediate basic skills in reading, math, and language for students preparing to enter a technical program and also those seeking a State of Florida High School Diploma (GED®). Once the minimum basic skills standards are achieved, the students may enroll in their technical program or GED® classes, based on their individual academic goals.

Completion of remedial classes is solely determined by consistent attendance, daily participation, and personal effort. As stated in the McFatter Technical College Student Handbook, students are expected to do their best and attend all sessions during the designated times, as specified on their registration receipts.

The AGE Department is located in the Academic Resource Center (ARC), on the west end of the campus. The facility has state-of-the-art technology in all classrooms.

## Program Content

The Adult Basic Education (ABE), Applied Academics for Adult Education (AAAE), Test of Essential Academic Skills (TEAS), and General Educational Development (GED®) are programs designed to enhance our students' basic skills level in an individualized fashion.

The AGE Department offers instruction and provides test taking strategies for each subject area of the Test of Adult Basic Education (TABE), as well as web-based computer programs targeting specific concepts for ABE, AAAE, TEAS, and GED® examinations.

## Admission Requirements

Schedule the Tests of Adult Basic Education (TABE) (\$15) in the Registration Office.

Schedule an appointment with your program counselor for TABE results and class registration.

Register for classes during open enrollment. Please be advised that registration runs on a first come, first served basis.

## Adult Basic Education (ABE)

The Adult Basic Education course of instruction is designed to improve the employability of the state's workforce through instruction in mathematics, reading, language, and workforce readiness for students who score below the ninth grade level on the Test of Adult Basic Education (TABE).

## Applied Academics for Adult Education (AAAE)

The AAAE program is designed for students who have tested at the equivalent of ninth grade and above but need to improve their basic skills to meet the requirements of a Career and Technical Education (CTE) program in which they are enrolled.

## Test of Essential Academic Skills (TEAS)

In order to help students prepare for a passing score on the TEAS, which is required for admission to the Practical Nursing (PN) program, a comprehensive preparatory course is offered. This course will focus on reading, math, science, and language.

## General Educational Development (GED®)

GED® test preparation includes reading, science, social studies, math and language. A prescriptive learning model meets our students' individual needs. Dedicated teachers work one-on-one to manage student progress in preparation of taking and successfully passing the GED® exam. The GED® Prep course is characterized by open-entry/open-exit, self-paced instructional modules, flexible schedules, and performance-based evaluation.

## Action Steps to Employment

Action Steps to Employment is a four week online program created to accelerate employment for our adult education students. It is designed to meet federal and state laws and the curriculum requirements of career education for adult education students. All AGE students will need to complete this four-week program during enrollment in their AGE course. Upon successful completion, a certificate for the student's resumé/portfolio will be awarded.
